I understand all of the laws and regulations set forth in the Code and will abide by them throughout the campaign. I also fully understand the penalties for violations of set laws and regulations contained in the Code. I will train my staff in the Code and will be entirely responsible for their actions. I also realize that if I am elected, and violations are discovered post factor, I can be removed from office. I acknowledged that this Code provides me with a limited privilege of confidentiality. I hereby acknowledge that I permanently waive this privilege if I release any information about a complaint to the public or appeal the Elections Commission's decision regarding a complaint. I am also aware that any information that I, or my campaign, submit to the commission in the course of my campaign will become public record. I was present at the Mandatory Candidates' Meeting on Sunday, February 9th, 2020 and I agree that I am responsible for the information set forth in the meeting. I am signing this of my own free will and accept to abide by what I am signing.
